INTRODUCTION

Welcome to the Indifly Privacy Policy. Indifly having its registered office at FL No.2, PL No. 61, Mangal- Murti Apartment, Bassaye Nagar, Aurangabad- 431001, Maharashtra, India and Corporate Office at Office No. 412, Tower 2, World Trade Center, Kharadi, Pune-411014, Maharashtra, India ("Indifly", "We", "Us", "Our") manages website (collectively referred to as "Platform" or "Websites") which inter alia engaged in the business of consultancy services. The term "User" or "Users" or "You" or "Your" means any individual or entity (person) which uses, accesses or browses the Website. At Indifly we are committed to safeguarding your personal information and privacy. This Privacy Policy outlines how we collect, use, disclose and protect your data when you interact with our Website, and use our services.

This document ("Privacy Policy") is an electronic record in terms of the (i) Information Technology Act, 2000; (ii) the rules framed there under as applicable; and (iii) the amended provisions about electronic records in various statutes as amended by the Information Technology Act, 2000. This electronic record is generated by a computer system and does not require any physical or digital signatures.

This Privacy Policy is published under the provisions of the Information Technology Act, 2000 and the rules made thereunder that require publishing the rules and regulations, privacy policy and terms of use for access or usage of our Website <u>info@indifly.in</u> (the "Website").

To provide you with access to use of the website, we have to collect and otherwise process certain data about you. This Policy explains how we process and use personal data about you. We value your trust and strive to be transparent about our practices. By using our website or services, you agree to the collection and use of information following this policy, as may be amended from time to time by us at our discretion. You also agree and consent to us collecting, storing, processing, transferring and sharing your personal information (including sensitive personal information) with third parties or service providers for the purposes set out in this Privacy Policy.

Please take a moment to review the details below to understand how we handle your information and what choices you have regarding your data and give consent to the collection, use, disclosure, and/or retention of your personal information in accordance with the processing activities described under this policy.

BACKGROUND

This Privacy Policy applies to all persons who access or use the website or the end-users of the Website ("You"). We regularly review and update our Privacy Policy. The personal data that we hold about you must be accurate. The Website may include links to third-party websites and applications ("Third Party Services"). We carefully analyse what type of information we need to provide our services, and we try to limit the information we collect to only what we really need. Where possible, we destroy or anonymize this information when it's not relevant. In all of this work, our guiding principle is that your information/data belongs to you, and we aim to only use your information/data to your benefit.

COLLECTION OF PERSONAL INFORMATION

The type of Personal Information we collect

You provide your information to us when you; such as the following categories of information are directly collected by us, and some are provided by you directly for the performance of certain functions:

- Accessing our Website;
- Enquiring about our Services;
- Registration for our services on our Website;
- Upload your contacts, including access to mobile device contacts for certain services;
- Communicate with us by phone, e-mail or otherwise;

As a result of the above-mentioned actions, you might also share the following information with us:

- Identifying information such as your name, address and phone number(s);
- Your date of birth;
- Your location information including your mailing address;
- Content of reviews and email to us;

Information collected automatically and stored includes:

- The IP address device's serial number or unique identification number;
- Email address and password;
- The location of your devices;

- Information you voluntarily disclose that may reveal certain characteristics about you such as your racial or ethnic origin or sexual orientation;

THIS INFORMATION MAY INCLUDE BUT NOT BE LIMITED TO THE FOLLOWING

- Identification Information such as name, gender, current district or state or country location, contact information such as email address, and mobile number;
- Usage Data, which includes information about how you use the Website, your activity on the Website, user taps and clicks, user interests, time spent on the Website, details about user journey and page views.

- Additional Information relevant to your use of our Websites and services such as OTP for registration, where the relevant Service of the Website requires such information.
- We also collect, use, and share aggregated data such as statistical or demographic data for any purpose. Aggregated data could be derived from your personal data but is not considered personal data under the law as it does not directly or indirectly reveal your identity. However, if we combine or connect aggregated data with your personal data so that it can directly or indirectly identify you, we treat the combined data as personal data which will be used in accordance with this Policy.

HOW DO WE COLLECT PERSONAL DATA?

We use different methods to collect personal information from and about you, including but not limited to, the:

- a. Direct Interaction: The personal information you provide when you:
 - i. use our website or carry out other activities in connection with the website or mobile application;
 - ii. Report a problem with the website, give us feedback, or contact us.
- b. Information we collect automatically: Each time you visit the website, we automatically collect data about your equipment, browsing actions and patterns. We collect information using cookies and other similar technologies to help distinguish you from the other users of our website.
- c. Information we receive about you from other sources: Sometimes you may have given your consent to other websites, services or third parties to provide information to us.
 - i. It could include information from the third parties that we work with to provide our products and services, such as delivery companies, technical support companies and advertising companies. Whenever we receive information about you from these third parties, we will only use it in such a manner that is already communicated to you, as per this policy, and for defined purposes only.

WHAT IF WHEN YOU REFUSE TO SHARE YOUR INFORMATION?

Where we need to collect personal data under the terms of this policy and you fail to provide that data when requested, we may not be able to perform the contract (for example, to provide you full access to the Website). In this case, we may have to cancel or limit your access to the Website.

HOW DO WE USE YOUR PERSONAL INFORMATION?

We will only use your personal information when the law allows us. Most commonly, we will use your personal information where we need to provide you with access to the website, or where we need to comply with a legal obligation. We may use your personal information outlined below including but not limited to:

- Necessary to protect the safety of our employees, our property, and our company.

You agree and acknowledge that we may share data without your consent when it is required by law or by any court or government agency or authority to disclose such information. Such disclosures are made in good faith and belief that it is reasonably necessary to do so for enforcing this Policy or the Terms, or in order to comply with any applicable laws and regulations.

We may use and/or disclose your information with the Company-controlled businesses, affiliates, and other entities within our group companies.

You agree and acknowledge that by using our Website and other features of the Website, you authorise us and our affiliates to contact you via email, phone, or otherwise. You ensure that you are aware of all the features of the Website.

YOUR RIGHTS OVER YOUR PERSONAL INFORMATION:

We believe your rights over your information are crucial.
